GIFT AID

Eligible donors can make their gifts go further by signing the Gift Aid declaration overleaf. If you are a UK taxpayer, the University can reclaim the tax you have paid on any charitable gift, as long as you have paid the equivalent amount of tax to the amount being reclaimed. This means we can claim an extra 25 pence for every eligible £1 donated, at no extra cost to the donor.
